The SGP Philosophy

It is our belief that theatre is the cooperative venture of many talents and that <u>every</u> actor is a valued and essential part of any successful production. However, as directors, it is our task to determine the most appropriate role for every actor - for their individual success and the ultimate good of the show. It is a daunting task, with many factors playing a part in the final decision. Yet, we pride ourselves in fostering an attitude of mutual respect, where all actors work hard as a team and are always kind to each other. Without a cooperative spirit and shared sense of pride in the final outcome, a truly successful production would never be possible.

- **CASTING** It is understood that role assignments are the final decision of the directors, always in the best interest of the show and *non-negotiable*. It is expected that performers accept their assignments with *grace and professionalism*. Any negative attitudes that prove counterproductive to the production may result in an actor's removal from the show (with no refund).
- **ATTENDANCE** We prefer that no more than <u>one</u> rehearsal be missed. *Rehearsals the week before and during tech week are mandatory*. Excessive absence and lateness could result in **role replacement** or being **removed from the show**. Please be prompt in dropping off and picking up performers from class.
- **DAYS/TIMES** Rehearsals are on **Wednesdays** (4:30-7:30 pm). *Not all cast members may be needed every rehearsal or for the entire time*. Specific schedules will be e-mailed the week prior to each rehearsal.

- **COSTUMES** Some costume pieces/tights/shoes may need to be provided for the performance.
